(KELANTAN), D.K. (JOHORE), D.K. (NEGERI SEMBILAN), COLLAR OF THE SUPREME ORDER OF THE CHRYSANTHEMUM, GRAND ORDER OF MUGUNGHWA, D.K. (PAHANG), Sultan and Yang Di-Pertuan of Negara Brunei Darussalam and all its Dependencies.”

The Chief Justice Sir Denys Roberts was conferred the title of SPMB first class His Majesty on his birthday which carries the title of Dato. The attestation to Writs should therefore now be worded as follows:
