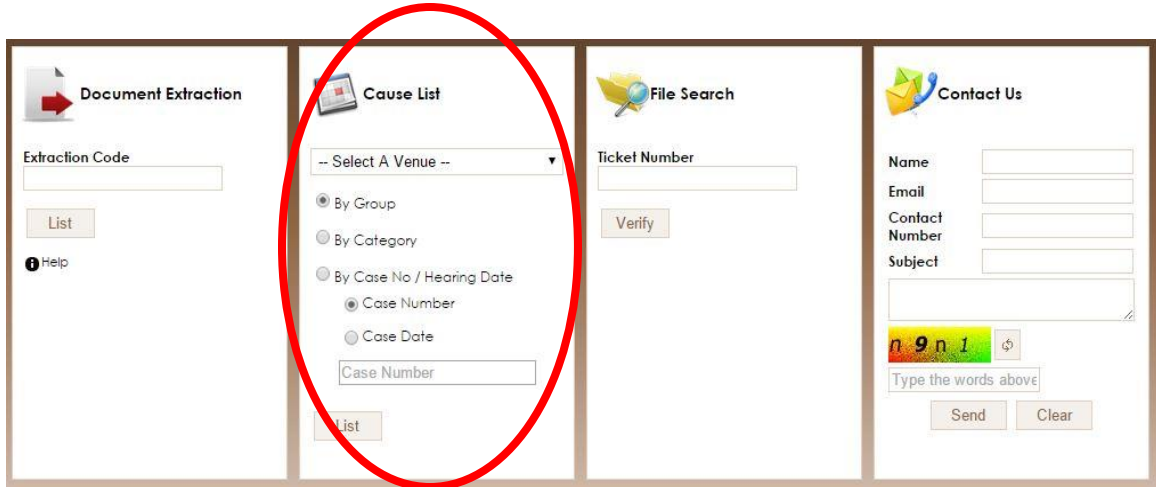


**GUIDE TO TRACKING CASE STATUS – HEARING DATES**

1. Enter <http://efiling.judiciary.gov.bn> into the URL box of your web browser. Locate the **CAUSELIST SEARCH BOX**.



2. You **MUST** select a venue from the dropdown menu. To identify the venue of a particular case, please refer to the **Case Number** assigned to the relevant case. If you are searching for the hearing dates in a particular court, select in accordance to LOCATION – TYPE OF COURT from the dropdown menu e.g. Bandar Seri Begawan – Bankruptcy Office.



- To search according to the **Case Number**, select “**By Case No / Hearing Date**” then “**Case Number**”. Enter the Case Number e.g. BCY/CP/472/2015. Click **LIST**. The dates of all scheduled hearings including future hearing dates and the relevant Judicial Officer for that particular case will be displayed in a new window accordingly.
