## Methodology:

The age of the active cases and adjourned sine die cases* = cases that are currently on-going for over 24 months before the Court, measured as the number of days from filing to the time of measurement.

The Court is monitoring both civil and criminal matters from all level of court, below is the list of cases included in the monitoring of ageing list;

Adjourned Sine Die (ASD) cases
ASD cases over 24 months $\times 100 \%$ Total ASD cases

This measurement indicates that the higher the percentage of ageing list, the higher the backlog of caseloads over 24 months that the court has.
Note:- *adjourned sine die cases are cases still in progress but without assigning a day for a further meeting or hearing due to several factors / circumstances.
