## Methodology:

The age of the **active cases** and **adjourned Sine die\* cases** = cases that are currently on-going for over 24 months before the court, measured as the number of days from filing until the time of measurement.

The cases that have been monitored in 2017 and 2018 are only civil matters from all level of court except Court of Appeal Civil Cases (COACV). In 2019, the court has started to monitor both civil and criminal matters from all level of court.




This measurement will show the higher the percentage of ageing list (Active cases and Adjourned Sine Die), the more on-going caseload over 24 months that the court has.

Note:- \*adjourned sine die cases are cases still in progress but without assigning a day for a further meeting or hearing due to several factors/circumstances.




